RE: Required Training Modules for 2023-2024

As part of our commitment to maintaining a safe and supportive work environment, all employees must complete the training courses listed below by **September 29, 2023**. These courses are essential in ensuring the well-being of our staff and those we serve. To access the training modules, please log in to Frontline Education, our new platform for human resources records.

Below is a list of the mandatory training courses, along with a brief description:

• Training 1: Erin's Law (Prevention of Abuse)

"Erin's Law" is a set of legislation aimed at preventing child sexual abuse and educating children about how to recognize and report inappropriate behavior. It is named after Erin Merryn, a survivor of child sexual abuse who has become an advocate for child safety education. An account must also be created at training.dhr.alabama.gov./.

• Training 2: Jason Flatt Act (Suicide Prevention-2 Hour Course)

"Jason Flatt Act" is a set of legislation addressing youth suicide prevention in schools. The act is named in memory of Jason Flatt, a young man who tragically took his own life and whose family has since become advocates for increasing awareness and education about youth suicide. • Training 3: Jamari Terrell Williams Act (Bullying Prevention)

The Jamari Terrell Williams Student Harassment Act places certain responsibilities on the Board of Education to ensure cyberbullying and bullying are not tolerated. It expands the current statute to prevent student against student harassment, intimidation, violence, and threats of violence to students off campus as well. It also specifically includes cyberbullying in the definition of harassment.

• Training 4: Alabama Educator Code of Ethics

The Alabama Educator Code of Ethics defines the professional behavior of educators in Alabama and serves as a guide to ethical conduct. The code protects the health, safety, and general welfare of students and educators, outlines objective standards of conduct for professional educators, and clearly defines actions of an unethical nature for which disciplinary sanctions are justified.

• Training 5: Annalynn's Law

Annalyn's Law (March 2018) is named after child victim, Annalyn Cook, who was sexually abused by a juvenile offender in Alabama. The law states that juvenile sex offenders must submit an application to all school property and functions and meet with school personnel to create and implement an individualized safety plan.
