Knowledge of CPR, first aid, and emergency techniques.

- *(40) Use a variety of instructional strategies appropriate for teaching students from diverse backgrounds with different learning styles and special needs.
- *(41) Use appropriate techniques and strategies to enhance the application of critical, creative and evaluative thinking capabilities of students.
- *(42) Use appropriate material, technology and resources to help meet learning needs of all students.
- *(43) Assist students in assessing, interpreting and evaluating information from multiple sources.
- *(44) Provide appropriate instruction and modifications for students with special needs, including special education students and students who have limited proficiency in English.
- *(45) Provide quality work for students which is focused on meaningful, relevant and engaging learning experiences.
- *(46) Provide instruction on safety procedures and proper handling of materials and equipment.
- *(47) Foster student responsibility, appropriate social behavior, integrity, valuing of cultural diversity, and respect for self and others by role modeling and learning activities.
