Ability to plan and implement activities for maximum effectiveness. Ability to assess levels of student achievement effectively, analyze test results and prescribe actions for improvement. Ability to maintain appropriate student supervision so that students have a safe and orderly environment in which to learn. Ability to work effectively with peers, administrators and others. Knowledge of basic first-aid and the health and safety requirements of the physical education program. Ability to work and teach outdoors for extended periods of time. Knowledge of CPR and its function. Ability to use computer-based programs that are used in the school system with proficiency.

- *(38) Monitor learning activities, providing feedback and reinforcement to students.
- *(39) Use a variety of instructional strategies appropriate for teaching students from diverse backgrounds with different learning styles, special needs and physical conditioning.
- *(40) Use appropriate techniques and strategies to enhance the application of critical, creative and evaluative thinking capabilities of students.
- *(41) Use appropriate materials, technology and resources to help meet learning needs of all students.
- *(42) Encourage students to develop skills and interests in life-long physical activities.
- *(43) Provide appropriate instruction and modifications for students with special needs, including special education students and students who have limited proficiency in English.
- *(44) Provide quality work for students which is focused on meaningful, relevant and engaging learning experiences.
- *(45) Check equipment and apparatus prior to use to ensure safety and proper working condition.
- *(46) Provide instruction on safety procedures and proper handling of materials, equipment and apparatus.
- *(47) Foster student responsibility, appropriate social behavior, integrity, valuing of cultural diversity, and respect for self and others by role modeling and learning activities.
- *(48) Communicate effectively, orally and in writing, with other professionals, students, parents and community.
